MUTUAL RECOGNITION TREATY & FRATERNAL ALLIANCE

BETWEEN THE

NATIONAL GRAND LODGE OF GREECE OF THE A.F.& A.M.

&

THE GRAND LODGE "ANDRES QUINTANA ROO"

IN VIEW OF

That the Treaty of Mutual Recognition between our powers demonstrates the fraternity and close relations of friendship between the Masons of the entire World and especially, the brethren of the **National Grand Lodge of Greece of the Antient, Free, and Accepted Masons** and the brethren of the **Grand Lodge "Andrés Quintana Roo"**

AND CONSIDERING

That the paradigm of this new millennium proclaims that all true Initiates work for a more effective, real, and lasting union of the Craft.

That we hereby enhance the pleasant interpersonal relationship between the brethren of our respective Grand Lodges, consolidating the vast Masonic social and cultural sphere, channeling it in favor of a growing exchange in these areas.

That the Masonic identity must be exalted and expanded through fraternal and exemplary actions, framed in the triptych of

FREEDOM, EQUALITY & FRATERNITY.

That it is the express will of our jurisdictions to mutually recognize each other to exalt the fundamental object of Freemasonry, which lies in fighting against ignorance in whatever form it presents itself, loving our fellow men and working tirelessly for the well-being of humanity and in particular that of our respective countries.

That the Masonic fraternity must be lived and felt through acts that seal the wills of the heart, spirit, and intelligence of all good Masons.

THEREFORE

THE NATIONAL GRAND LODGE OF GREECE
OF THE ANTIENT, FREE, AND ACCEPTED MASONS
&
THE GRAND LODGE "ANDRES QUINTANA ROO"

RESOLVE

Art. 1. Fully respecting the basic principles for Grand Lodge recognition accepted by Grand Lodge of England, on September 4, 1929, the Parties Hereby agree upon, validate and ratify the Treaty of Mutual Recognition and Fraternal Alliance in force between both Powers, declaring that they currently maintain and for the future, an imperishable union of wills and common purposes between them.

Art. 2. The Parties hereby recognize each other as regular Symbolic Grand Lodges in their jurisdictions and therefore any further recognition by them of another Grand Lodge in the territorial jurisdiction of the Parties to this Agreement shall require as necessary and sufficient condition their consent, respectively. Both Grand Lodges admit the Ancient Boundaries or Landmarks and the Declaration of the Basic Principles for the Recognition of Grand Lodges as an essential part of universal Masonic legislation.

Art. 3. The High Contracting Parties undertake to continue to strengthen ever more intensely the ties of friendship, harmony, and concord between the brethren of the

and the

" THE GRAND LODGE ANDRES QUINTANA ROO "

, in pursuit of an ever stronger union of Universal Freemasonry.

Art. 4. The High Contracting Parties solemnly undertake to continue providing mutual assistance and permanent cooperation, within the framework of their respective jurisdictions.

Art. 5. The High Contracting Parties will continue to carry out social, cultural, and Masonic exchanges between both countries through groups made up of Brethren of the signatory Grand Lodges, with the aim of positively combining the work developed by them.

Art. 6. The High Contracting Parties will welcome the opportunities to carry out joint work in the elaboration and execution of social development programs and support to service institutions.

Art. 7. Recognize the signatory Grand Master's as sole and legitimate representatives of Regular Freemasonry in their respective jurisdictions.

Art. 8. The High Contracting Parties agree to continue appointing Grand Representatives and/or Guarantors of Peace and Friendship at the proposal of each other, which will allow for a more fluid communication and therefore better relations between both Grand Lodges.

Art. 9. The High Contracting Parties consider the terms of this Treaty to be just, true, and due, forcing each other to comply with them, now and forever, as long as the columns of both Powers remain upright.

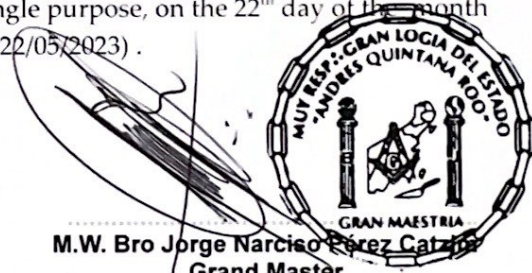
